Wearing household latex or rubber gloves, use a dust applicator such as a shaker can, dust gun, puffer or other bulbous duster, rotary duster or other appropriate duster as available. Start applying at the farthest corner of the treatment area and work backward to avoid contact with dusted surfaces. Dust lightly to cover both upper and lower leaf surfaces with a thin, even film of dust. (Many insects hide on the underside of the leaf). **Apply when air is calm to avoid drift and contact with eyes and skin.**

Controls a wide range of insect pests. Use at first signs of insect infestation, preferably before damage from feeding occurs. **Note the pre-harvest (time between use and harvest) interval with each crop listed.**

Broccoli, Brussel Sprouts, Cauliflower	Cabbage Looper, Imported Cabbageworm, Diamondback Moth, Cabbage Aphid	Dust lightly. Apply up to 8 times per season. May be applied until 1 day before harvest.
Cabbage	Cabbage Looper, Imported Cabbageworm, Diamondback Moth, Cabbage Aphid	Dust lightly. Apply up to 5 times per season. May be applied until 1 day before harvest.
Cucumber, Muskmelons, Pumpkin, Squash, Watermelon	Leafminer, Squash Bug, Cabbage Looper, Cucumber Beetle (adult), Cutworm, Melon Worm, Pickle Worm, Plant Bug (including Lygus and Stink Bug), Rindworm, Squash Vine Borer	Dust lightly. Apply up to 8 times per season. May be applied until harvest.
Celery, Lettuce (head and leaf), Parsley, Rhubarb, Spinach	Vegetable Leafminer, Cabbage Looper, Cutworm Complex, Fall Armyworm, Beet Armyworm, Corn Earworm, Leafhopper, European Corn Borer	Dust lightly. Apply up to 5 times per season. May be applied until 1 day before harvest.
Eggplant	Colorado Potato Beetle, Vegetable Leafminer, Cabbage Looper, Flea Beetle	Dust lightly. Apply up to 10 times per season. May be applied until 3 days before harvest.
Onions (Dry bulb and Garlic)	Onion Thrips, Armyworm, Cutworm, Leafminer, Onion Maggot (adult), Stink Bug	Dust lightly. Apply up to 6 times per season. May be applied until 1 day before harvest.
Peppers (Bell)	Pepper Weevil, Vegetable Leafminer, Cabbage Looper, Flea Beetle, European Corn Borer	Dust lightly. Apply up to 8 times per season. May be applied until 3 days before harvest.
Potatoes	Colorado Potato Beetle, Potato Leafhopper, Aster Leafhopper, Potato Flea Beetle, Potato Aphid, Potato Tuberworm, Potato Psyllid, Cabbage Looper	Dust lightly. Apply up to 8 times per season. May be applied until 14 days before harvest.

Sweet Corn	Corn Earworm, European Corn Borer, Fall Armyworm, Southern Armyworm, Corn Rootworm (adult), Cutworm, Aster Leafhopper, Flea Beetle	Dust lightly. Apply up to 6 times per season. May be applied until 1 day before harvest.
Tomatoes	Tomato Fruitworm, Cabbage Looper, Tomato Pinworm, Vegetable Leafminer, Beet Armyworm, Southern Armyworm, Colorado Potato Beetle, Granulate Cutworm, Hornworm	Dust lightly. Apply up to 6 times per season. May be applied until day of harvest.

ORNAMENTALS: DIRECTIONS FOR APPLICATION

CROP	TARGET PEST	REMARKS
Asparagus Fern	Japanese Beetle, Asparagus Beetle, Lygus Bug	Dust lightly. Apply to the fern stage of asparagus plant after spear harvest when adult stage of the asparagus beetle, lygus bugs and the adult stage of the Japanese beetle are present.
Roses	Beet Armyworm, Cabbage Looper, Omnivorous Leafroller	Dust lightly.

TREE CROPS: DIRECTIONS FOR APPLICATION

Dust lightly, using a dust gun or rotary duster.

CROP	TARGET PEST	REMARKS
Apples	Apple Aphid, Redbanded Leafroller, Obliquebanded Leafroller, Plum Curculio, White Apple Leafhopper, Spotted Tentiform Leafminer, Tarnished Plant Bug	Dust lightly. Do not apply after petal fall.
Peaches	Peach Twig Borer, Oriental Fruit Moth, Green Fruitworm, Lesser Peachtree Borer, Plum Curculio, Tarnished Plant Bug	Dust lightly. Apply up to 5 times per season. May be applied until 14 days before harvest.
Walnuts	Navel Orangeworm, Codling Moth, Walnut Husk Fly	Dust lightly. Apply up to 8 times per season. May be applied until 1 day before harvest.
