The International Agency for Research on Cancer (IARC) lists chlorophenoxy herbicides in its Group 2B (limited evidence for carcinogenicity in humans.) The US EPA has given the chlorophenoxy herbicides 2,4-D, 2,4-DP, MCPP, and MCPA a Class D classification (not classifiable as to human carcinogenicity.) More current 2,4-D lifetime feeding studies in rats and mice did not show carcinogenic effects and a recent World Health Organization (WHO) review of 2,4-D toxicology has concluded that 2,4-D is not a carcinogen.

4. First Aid Measures:

Route(s) of Entry:

Skin contact, Inhalation, Ingestion.

Health Hazards (Acute and Chronic):

EYES: May cause substantial but temporary eye damage.

SKIN: Moderately irritating to the skin; Repeated or prolonged contact may result in absorption through the skin.

INHALATION: Moderately irritating to the mucous membranes.

INGESTION: May be irritating to the respiratory tract.

Signs and Symptoms:

Inhalation may cause burning in the chest, with coughing and dizziness.

IF SWALLOWED: Drink promptly a large quantity of milk, eggwhites, gelatin solution or if these are not available, large quantities of water. Avoid alcohol. Do not induce vomiting. Get medical attention.

INHALATION: Remove victim to fresh air. Apply artificial respiration if needed. ENVIRONMENTAL HAZARDS:

This product is toxic to aquatic invertebrates. Drift or runoff may adversely affect aquatic invertebrates and nontarget plants. Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwater. When cleaning equipment, do not pour the washwater on the ground; spray or drain over a large area away from wells and other water sources. Do not apply when weather conditions favor drift from target area. Do not contaminate domestic or irrigation waters.
